Informational Bulletin Regarding Emergency Declaration – Winter Storms

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

On March 1, 2023 California Governor Gavin Newsom proclaimed a State of Emergency in Amador, Kern, Los Angeles, Madera, Mariposa, Mono, Nevada, San Bernardino, San Luis Obispo, Santa Barbara, Sierra, Sonoma, and Tulare counties to support disaster response and relief due to recent winter storms.
