Health Plan Coverage of Preventive Services APL 23-009

This is an advisory notification to Molina Healthcare of California (MHC) network providers regarding the coverage of Preventative Services as required by the Knox-Keene Health Care Service Plan Act.

BACKGROUND

The Knox-Keene Health Care Service Plan Act (Knox-Keene Act) imposes an independent duty on health plans to cover preventive services.

POLICY

Preventive services that MHC will cover under the Knox-Keene Act without costsharing or prior authorization include, but are not limited to:

- Screenings for certain cancers and sexually transmitted diseases, behavioral health screenings, and diabetes screenings (USPSTF)
- Immunizations recommended by the Advisory Committee on Immunization Practices of the federal Centers for Disease Control and Prevention.
- Preventive care and screenings supported by the United States Health Resources and Services Administration.
- Preexposure and postexposure HIV prophylaxis drugs
- FDA approved contraceptive drugs and devices
