# Intermediate Care Facility for Developmentally Disabled Carve-In 101 Webinar

This is an advisory notification to Molina Healthcare of California (MHC) network providers with details on the upcoming CalAIM: Intermediate Care Facility for the Developmentally Disabled (ICF/DD) Carve-In 101 webinars for ICF/DD Homes.

## What you need to know:

Beginning January 1, 2024, all managed care plans (MCPs) will be required to cover and coordinate institutional long-term care for members entering or currently residing within an ICF/DD Home. DHCS is hosting virtual webinars to support ICF/DD Home providers and Medi-Cal MCPs as they prepare for MCP coverage of ICF/DD Home services statewide. The goal of these educational webinars is to provide stakeholders with information about the ICF/DD Carve-In policy requirements and how to best support and coordinate care for members.

The webinars will feature several topics including ICF/DD Carve-In 101, promising practices for contracting, billing, and payment, and best practices for care transitions and care management. ICF/DD Home providers are encouraged to attend. All webinars are open to the public.

### When this is happening:

The second in a series of educational webinars for ICF/DD Long-Term Care Carve-In is on **Monday, August 21 from 2:30 p.m. - 4:00 p.m.** This webinar will focus on providing ICF/DD Home providers and Regional Centers with an understanding of the ICF/DD Carve-In components, Medi-Cal MCP responsibilities, and overall readiness for when the ICF/DD Carve-In goes into effect.
