Upcoming Changes: Home Health Prior Authorization Code Matrix Update

Molina is updating the Medicaid Prior Authorization (PA) Code Matrix effective **September 7, 2025**. This is a notification only and does not determine if the benefit is covered by the member's plan. The prior authorization requirements for the following codes have been updated. For specific CPT/HCPC codes requiring PA please review the PA Code Matrix. All Home Health Services will require authorization:

The process for obtaining prior authorization has not changed. Requests for amounts over the allowable limits and requests for non-payable codes will require prior authorization. Please complete the Prior Authorization / Service Request Form with all pertinent information and provide relevant medical notes as applicable.
