Provider Credentialing, Screening, and Enrollment

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

WHAT YOU NEED TO KNOW:

Per All-Plan Letter (APL) 22-013, all Providers currently in MHC's network and those looking to join the network are mandated to enroll in the Medi-Cal Program. This requirement to enroll in the Medi-Cal Program applies to all MHC Providers, including those participating through an IPA. If a Provider who is currently active with MHC fails or declines to complete their enrollment in the Medi-Cal Program, MHC will be required to terminate their participation from the network.

HOW TO ENROLL:

The Provider Enrollment Division (PED), a unit within DHCS, is responsible for the timely enrollment of Providers into the Medi-Cal Program. PED now offers an improved web-based application via their Provider Application and Validation Enrollment (PAVE) portal. Please note the current PAVE release may not support specific Provider types or submissions from new out-of-state Providers. PAVE is being implemented in a series of releases to include Provider types and enrollment actions.
