DRUGMAKER ORDERED TO PROVIDE FREE NALOXONE TO FIRST RESPONDERS

The California State Board of Pharmacy reached a settlement with the McKesson Corporation that will enforce the company to provide \$1.5 million worth of free naloxone, an opioid overdose-reversing medication, to California first responders. The drugmaker has been reprimanded for failing to report suspicious orders of often abused opioid painkillers in connection with prior violations.
