Enhancements to Authorization

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Marketplace line of business.

What you need to know:

Molina Healthcare has introduced a new automated authorization tool available through the Availity Essentials Provider Portal. This tool uses Milliman Care Guidelines (MCG) criteria to determine medical necessity and may automatically approve requests that meet the requirements, streamlining your workflow and reducing delays.

This update applies to in-network providers and includes specific Marketplace CPT codes across five categories:

- Arthroscopy
- Electroencephalogram (EEG)
- Gynecology
- Podiatry
- Sleep studies

Requests containing only the included codes may be auto approved. However, any request that includes a mix of eligible and ineligible codes will be routed to Molina for manual review.

To begin using the automated authorization tool in the Provider Portal:

Step 1: Confirm your authorization role with your organization's Availity administrator.

Step 2: Log into Availity Essentials and navigate to: *Patient Registration > Authorizations and Referrals*

Step 3: Submit authorization requests for applicable CPT codes and record the reference number in the patient's medical record.

Note: If your request includes one of the codes below **plus** a code not in the Auto Auth program, the request will pend and be routed to Molina for review.
