Q2 2023 Updated Prior Authorization (PA) Code Matrix

This is an advisory notification to Molina Healthcare of California (MHC) network providers regarding the updated Prior Authorization Code Matrix, formerly referred to as the "Codification Document".

MHC has updated our prior authorization code matrix and the primary updates include modifications to the following specialties/services:

For Medi-Cal, Medicare, Duals, and Marketplace:

- Behavioral/Mental Health, Alcohol-Chemical Dependency
- Cosmetic, Plastic & Reconstructive Procedures
- Durable Medical Equipment (DME)
- Genetic Counseling & Testing
- Healthcare Administered Drugs
- Neuropsychological and Psychological Testing (in any setting)
- OP Hosp/Ambulatory Surgery Center (ASC) procedures

The PA Code Matrix is available online via the provider portal as well as our public website. Please note that this document is updated at least quarterly and is subject to change. It is advised that you check this document prior to PA submission as codes may be removed or added. All codes listed require PA.
