Trauma-Informed Programs and Practices Grant

This is an advisory notification to Molina Healthcare of California (MHC) network providers on the Children and Youth Behavioral Health Initiative (CYBHI) statewide grant application process and funding opportunity for Trauma-Informed Programs and Practices.

As part of the CYBHI, on February 9, 2023, the Department of Health Care Services (DHCS) released a Request for Applications (RFA) seeking proposals for Round Two of the Evidence-Based and Community-Defined Evidence Practices (EBP/CDEP) Grant Program, which aims to scale trauma-informed programs and practices based on robust evidence for effectiveness, impact on racial equity, and sustainability. DHCS will award up to \$75 million in grant funding to individuals and entities to deliver services offered to parents, caregivers, and children and youth with emerging or existing mental health and/or substance use disorders. Interested parties must apply for funding by **April 10, 2023, at 5 P.M.**

Scale is defined as expanding an organization's operations or capacity to deliver services, enabling replication and adaptation of well-established practices, and/or exploring policy innovations. DHCS encourages all interested parties to apply. Eligible grant recipients include but are not limited to:

- Community Organizations
- Educational Institutions
- Healthcare Facilities
- Government Agencies

The EBP/CDEP Grant Program offers two types of grant funding tracks. Grant award amounts will vary based on evaluation against program criteria, including track, practices employed, and level of impact. Eligible recipients can submit a proposal to a single track or an integrated proposal that includes activities across the following tracks:

- The Training Track scales individual practitioner capacity
 - Maximum Grant: \$10,000
- The Implementation Track scales organizational capacity
 - Start-Up: Designed for organizations seeking start-up funds
 - Maximum Grant: \$750,000
 - Operational Expansion: Designed for organizations looking to expand existing programs or scale delivery
 - Maximum Grant: \$400,000

How to Apply

All applications must be submitted by April 10, 2023, at 5 P.M. PST to be considered in Round Two. DHCS aims to make Round Two grant award announcements by June 30, 2023.

Practices and programs that are appropriate and/or can be adapted for focus populations will be prioritized, including the following EBPs/CDEPs:

- Attachment and Biobehavioral Catch-Up
- Child Parent Psychotherapy
- Dialectical Behavior Therapy
- Family Centered Treatment
- Modular Approach to Therapy for Children with Anxiety
- Depression, Trauma, or Conduct Problems
- Trauma-Focused Cognitive Behavioral Therapy
- Multisystemic Therapy
- Crossover Youth Practice Model
