Homeless Hiring Tax Credit

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

Molina encourages providers to hire individuals with lived experience of homelessness. This lived experience provides immense value, especially in supporting Molina members who are exiting homelessness.

The Homeless Hiring Tax Credit (HHTC) is available for taxable years beginning January 1, 2022 through December 31, 2026. Employers may receive \$2,500 to \$10,000 in tax credit per eligible employee based on the actual hours worked in the taxable year. Employers may claim up to \$30,000 of credit per taxable year.

To be eligible, the employee must be certified by a certifying organization, such as a local Continuum of Care (CoC) and community-based service providers. A certifying organization will confirm employer and employee eligibility and provide the certification for the employer.

Employers must make a tentative credit reservation with the Franchise Tax Board (FTB) to claim the credit. Employers will claim the credit when they file their tax return. A total of \$30 million of credit is available annually.
