### Medi-Cal Justice-Involved Reentry Initiative-Related State Guidance APL 23-030

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

#### What you need to know:

The objective of the Medi-Cal Justice-Involved Reentry Initiative is to create a pathway to community-based care for Medi-Cal members transitioning from incarceration. This initiative provides services to these members for up to 90 days prior to their release, with the goal of stabilizing health conditions, reintegrating them into their communities, and providing them with continuity of coverage. The DHCS is collaborating with state agencies, counties, providers, and community-based organizations (CBOs) to coordinate this community reentry process and improve health outcomes for justice-involved populations.

Justice-involved members may receive the following prerelease services covered under Medi-Cal:

- Reentry case management services
- Physical and behavioral health clinical consultation services
- Laboratory and radiology services
- Medications and medication administration
  - Medications for addiction treatment (MAT)
  - Medication-related counseling
  - Outpatient-prescribed medications
  - Over-the-counter (OTC) drugs

#### **Provider Action**

MHC may impose Corrective Action Plans (CAPs) or administrative and monetary sanctions for non-compliance.

- Durable medical equipment (DME)

On October 20, 2023, the DHCS released the Policy and Operational Guide for Planning and Implementing CalAIM Justice-Involved Reentry Initiative, a comprehensive outline of implementation and compliance program requirements. This guide is subject to updates on an ongoing basis in order to reflect evolving regulatory guidance.
