## Informational Bulletin Regarding Emergency Declaration – Palos Warehouse Fire

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to all lines of business.

### What you need to know:

On June 20, 2026, Governor Gavin Newsom issued a State of Emergency for Los Angeles County due to the active warehouse fire in the Boyle Heights area. The incident has produced significant smoke and particulate matter that may affect air quality in surrounding neighborhoods.

The emergency proclamation authorizes the California Governor's Office of Emergency Services (Cal OES) and state agencies to provide additional assistance and resources as needed to support response and recovery efforts.

Individuals living in or near Boyle Heights are advised to follow direction from local authorities, stay informed on air quality updates, and limit exposure to impacted areas while emergency operations continue.
