03/13/2026	Initial Health Appointment – APL 26-001 IE LA SAC SD	<ul style="list-style-type: none"> <li>IPA/MSO Primary Care</li> </ul>	<ul style="list-style-type: none"> <li>Medi-Cal</li> </ul>	APL 26-001 reviews the requirements for completing an Initial Health Appointment (IHA) for new Medi-Cal members within 120 days of enrollment. An IHA must include a history of the member’s physical and behavioral health, an identification of risks, an assessment of need for preventive screens or services and health education, and the diagnosis and plan for treatment of any diseases.
