Informational Bulletin Regarding Emergency Declaration – Winter Storms

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

On January 4, 2023 California Governor Gavin Newsom proclaimed a State of Emergency throughout California to support the ongoing response to recent winter storms.
