## ReferWell

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medicare line of business.

#### What you need to know:

MHC is dedicated to providing our members with the highest quality healthcare experience. Preventive care is crucial for the early detection of serious health conditions, and we are partnering with ReferWell to support our members in staying up to date with their preventive screenings.

Through this partnership, ReferWell is launching an outreach program to assist MHC members who are overdue for essential services, including Annual Wellness Visits, Breast Cancer Screenings, and Colorectal Cancer Screenings. ReferWell's care navigators will contact these members and may also collaborate directly with MHC network providers and offices to coordinate the scheduling of these vital services.

ReferWell streamlines the process by scheduling in-network appointments for patients and using their technology to send automatic appointment confirmations and reminders. This reduces the administrative workload for provider offices and helps minimize patient no-show rates. The program aims to close gaps in care, enhance care delivery integration, and capture valuable patient feedback. The feedback and screening results are then shared with the patient's primary care provider, ensuring continuity of care.
