

ANNOUNCEMENT – Medicaid registration with the state of Idaho

Announcement: Important information regarding your Medicaid registration with the state of Idaho

Effective January 1, 2026, the Idaho Department of Health & Welfare (IDHW) will require all providers to register to participate in Medicaid programs. To meet state registration requirements, Molina Healthcare of Idaho will be working with IDHW to ensure Medicaid registrations are current and complete. This new regulation aims to ensure high standards of care, enhance patient safety, and to maintain the integrity of claims processing for payment with Molina. The state of Idaho has started sending Molina a daily list of all registered providers. Starting January 1, 2026, if you are on IDHW's list, there is no additional action required other than to maintain your registration. If you are not on the list, that may mean you are not registered with IDHW and we encourage you to reach out to them to review your registration. If your registration is not updated by January 1, 2026, your Molina provider profile will be updated to a "No Pay" contract and claims submitted for payment may be disrupted.

Also, please note that starting August 31, 2025, the Molina Legacy portal will no longer be available. If you have not transitioned to Availity, please do so now. If Molina does not have your Medicaid identification number on file **and loaded to your Availity profile**, it may result in a disruption in your claim payments. For questions regarding:

Instructions for Idaho State Medicaid Registration

If you are not already registered with the state of Idaho and do not have a Medicaid ID, please follow the steps below. If you are registered, we also encourage you to check the state's website for confirmation.

Step 1: Prepare Necessary Documents

Before beginning the registration process, ensure you have the following documents ready:

- Proof of identity (such as a government-issued ID)
- Professional certification(s) and license(s)
- Proof of residence or business location in Idaho*
- Professional background and work experience details

*This is dependent upon on how you are registered with the state.

Step 2: Access the Online Registration Portal

Visit the official Idaho State Health Board website and navigate to the health care provider registration section.

Step 3: Complete the Registration Form

Fill out the online registration form with accurate and up-to-date information. Be sure to include all required documents and details.

Step 4: Submit Application

Once the form is completed, submit your application online.

Step 5: Await Confirmation

After submission, your application will be reviewed by the Idaho State Health Board. Upon approval, you will receive a confirmation email with your registration details and next steps.
