  - Molina's Prior Authorization (PA) Requirements, 3Q 2023—Review the quarterly updates to our PA requirements before they go into effect July 1, 2023!
  - <u>Rate/Fee Schedule Updates, May 2023</u>—This is the new rate/fee schedule in alignment with HFS.
     Remember, this is for the **Medicaid** line of business!
  - <u>Register for May Provider Webinars</u>—We have some great **live** sessions coming up, like Quality Improvement, Availity Essentials Portal & SSO, Online Tools Roadmap, and many different billing webinars. Hope to see you there!
  - <u>Availity Essentials Training Includes Legacy Portal Access!</u>—Learn how to use Availity Essentials
    to access the Legacy Portal. **Note**: We refer to this function as SSO or Single Sign On.
  - <u>Proper Use of Urgent (Expedited) Requests vs. Non-Urgent (Routine)</u>—Expedited requests are
    reserved **only** for instances of potential serious deterioration in the member's health or impact on
    member's ability to regain maximum function.
  - Get To Know 'Molina Guided Care'—Introducing Molina Guided Care, our innovative approach to palliative care services. This is **not** hospice care.
  - <u>Updates to Molina Clinical Policies</u>, <u>1Q 2023</u>—Note these key updates from the February MCPC meeting. HFS coverage rules supersede any Molina Clinical Policies.
  - NCH Oncology and Cardiology Prior Auth—Portal Access for Providers—Important: NCH portal
    access is critical in obtaining the necessary Prior Authorizations for non-pediatric oncology and
    cardiology. This is for Medicaid and Duals only!
  - Prior Auth Required for All Types of Therapy When PHE Ends May 12, 2023—Remember that
    physical therapy, occupational therapy, and speech therapy require Prior Authorization (PA)
    from Molina.

  - NCH Oncology and Cardiology Processes Are Live—We delegated non-pediatric cardiology and oncology to New Century Health on April 1, 2023. Again, Medicaid and Duals only!
