Per the Centers for Medicare & Medicaid Services (CMS), the Medicare-Medicaid Alignment Initiative (MMAI) demonstration program is ending on December 31. Therefore, Molina is transitioning from MMAI (also called MMP/Duals) to FIDE-DSNP on January 1, 2026. Learn about the DSNP plan and how it differs from MMP/Duals.
