

# Provider Memorandum

## HFS Issues Procedure for Double Psych Add-On

Molina Healthcare of Illinois (Molina) is aligned with the Illinois Department of Healthcare and Family Services’ (HFS) position regarding add-ons on the “Psychiatric FS” tab. These Psychiatric add-ons are in addition to those on the “Psych add-ons in CMHC” tab if criteria for both add-ons are met.

Therefore, under applicable conditions, CMHC providers are to receive both add-ons listed under “Psych add-ons in CMHC” and “Psychiatric FS.” HFS instructs that this is effective beginning with dates of service (DOS) July 1, 2019.

### Applicable Conditions

If the physician or Advanced Practice Nurse (APN) is board-certified in psychiatry (i.e., has a psych specialty) and billed on rendering field, he/she will get the add-on shown on the “Psychiatric FS” tab of the Practitioner Fee Schedule. If the code was billed with the UB modifier as an attestation that the service was provided in partnership with a participating CMHC—and the CMHC is the billing provider—then he/she will **also** get the add-on shown on the “Psych add-ons in CMHC” tab of the Practitioner Fee Schedule.

If, however, the psychiatrist or Advanced Practice Nurse (APN) is board-certified but is the billing provider—such as CPT 90791 without the UB modifier—then only the **one** add-on for \$23.57 on the “Psychiatric FS” tab would be payable.

### Example of Double Psych Add-On

Procedure Code and fees: Code 90791—\$122.11 + \$23.57 + \$30.00 = \$175.68
