



**PASSPORT BY MOLINA HEALTHCARE
GSD PARTICIPATING PROVIDER SWEEPSTAKES
OFFICIAL RULES**

1. **INITIATIVE OF THE SWEEPSTAKES:** To improve the GSD and manage diabetes by increasing the number of participating providers of Passport by Molina Healthcare (“Passport”) that achieve NCQA 50th percentile for HEDIS measure Glycemic Status Assessment for Patients with Diabetes (GSD) (<8.0%) for the measurement year 2025. Diabetes retinopathy is the number one cause of blindness among working age adults. Even though 95% of vision loss cases are preventable with early detection and treatment, only about half of patients with diabetes visit the eye specialist for annual retinal exams. By offering as the Prize a RetinaVue camera, Passport primary care providers will be able to offer more comprehensive care to their members.

2. **OFFICIAL RULES:** All Eligible Entrants accept and agree to these Official Rules and the decisions of the Sponsor, which shall be final in all matters. By participating in this Sweepstakes, Entrants each agree to be fully and unconditionally bound by the terms and conditions of these Official Rules and represent and warrant that they meet the eligibility requirements, are in compliance with the entry requirements in all regards and agree to accept the decisions of Sponsor in its sole discretion as final and binding as it pertains to this Sweepstakes. 4. **NO PURCHASE NECESSARY TO ENTER OR WIN:** PURCHASE WILL NOT INCREASE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

5. **HOW TO ENTER:** Beginning on January 1, 2025, at 12:00 AM EST through December 31, 2025, at 11:59 PM EST, in order to increase the number of Molina members with GSD results reflecting good status such that participating primary care providers who achieve the NCQA 50th percentile benchmark for GSD <8.0% for their members, will be notified by Passport that they are qualified to be entered into the Sweepstakes and become an Eligible Entrant, as limited below. Providers must respond to the notification by December 31, 2025. Passport will monitor and analyze the GSD <8.0% measure closure rates on a monthly basis to determine which providers are qualified to be Eligible Entrants. Eligible Entrants are limited to Passport participating primary care providers who are physician groups not employed by a hospital, with a

location in Kentucky, that serve diabetic Passport members. Individual IPA groups may be Eligible Entrants. Physician groups with less than five (5) diabetic Passport members or who previously won a RetinaVue camera in a prior Sweepstakes year are not Eligible Entrants. Any Passport participating primary care provider who has an immediate family member or persons living in the same household as a Molina Healthcare employee are also not Eligible Entrants. Alternatively, Passport participating providers can enter the Sweepstakes by sending an entry in writing to Passport at phpdiabetessweepstakes@molinahealthcare.com with the participating provider's identifying information and a contact person for the provider. Collectively, Eligible Entrants and alternative entries submitted via email shall be "Eligible Entries".

6. **PRIZE:** Five (5) handheld RetinaVue cameras, each with an estimated Prize value of \$11,680.00, which will enable a provider to obtain high quality retinal images in the primary care setting. Offering diabetic retinal exams during routine primary care office visits is a convenient and affordable way to ensure patients with diabetes get an annual retinal exam. Winner will be responsible for any ongoing or maintenance fees associated with using the Prize. RetinaVue Network Software Plan is \$188.00 per month for a total of \$2,256.00 per year. The Prize includes 12 months pre-paid RetinaVue Network Software Plan. Thereafter, each winner is responsible for any and all ongoing software plan expenses. Sponsor reserves the right to substitute a prize of equal or greater value in its sole discretion. If a potential winner is disqualified for any reason or declines the Prize, Sponsor will award the applicable Prize to an alternate winner by random drawing from among all remaining Eligible Entries. Potential winners will be notified directly by mail and/or email and must confirm receipt in writing within 7 days of the date notice is sent or such other date set by Sponsor. Failure to respond within the applicable period will result in forfeiture of Prize and Sponsor shall have the option to award the Prize to an alternate winner in its sole discretion. The failure to confirm receipt of the Prize notification and agreement to these Official Rules or any return of the Prize as undeliverable or unaccepted may result in disqualification and an alternate winner will be selected from all remaining Eligible Entries.
