

Prior Authorization Updates & Limits: Speech Therapist, Occupational

Therapist & Physical Therapist Providers

Molina Healthcare of Nevada cares about our members' health and is continually enhancing our online tools to improve quality of care. Prior Authorization updates have been added to our Prior Authorization LookUp Tool relating to the following services: physical therapy (PT), occupational therapy (OT) and speech therapy (ST).

Each code will allow 12 units per therapy per calendar year then require prior authorization if exceeded.

Speech Therapy: Require Modifier GN and/or Provider specialty: SPEECH/LANGUAGE/HEARING SPECIALIST/TECHNOLOGIST, SPEECH-LANGUAGE ASSISTANT, SPEECH THERAPY, HEARING AND SPEECH CLINIC/CENTER, SPEECH THERAPY

Occupational Therapy: Modifier GO and/or Provider specialty: OCCUPATIONAL THERAPIST, OCCUPATIONAL THERAPY ASSISTANT, PEDIATRIC OCCUPATIONAL THERAPIST, OCCUPATIONAL MEDICINE CLINIC/CENTER, HAND OCCUPATIONAL THERAPIST, OCCUPATIONAL THERAPY

Physical Therapy: Modifier GP GERIATRIC PHYSICAL THERAPIST, ORTHOPEDIC PHYSICAL THERAPIST, PEDIATRIC PHYSICAL THERAPIST, PHYSICAL MEDICINE & REHABILITATION, PHYSICAL THERAPY, PHYSICAL THERAPY ASSISTANT, PHYSICAL THERAPY CLINIC/CENTER, SPORTS PHYSICAL THERAPIST
