

Attention Provider:

Effective December 1, 2022, the STAR+PLUS Long-Term Services and Supports Billing Matrix is being updated to comply with Electronic Visit Verification (EVV) and the National Correct Coding Initiative (NCCI) standards.

<u>Due to these changes, your current LTSS authorizations will end on November 30, 2022 and new authorizations will be effective December 1, 2022. Your new authorizations will be created by October 15, 2022 to reflect the LTSS billing updates and sent to you. They will also be available via the Molina portal.</u>
