



Diabetes Rewards Program

Who is eligible for the Diabetes Rewards Program?

- HealthChoice Illinois members aged 18-75 diagnosed with type 1 or 2 diabetes.

Why should we participate?

- ✓ Members who take good care of their diabetes can improve their health and reduce the chance of eye damage, heart disease, and stroke.
- ✓ Members who qualify and complete certain health visits may earn a \$25 gift card for each test!

Diabetic Control- HbA1c control <8.0%

What is A1C testing?

- This test should be completed at least annually. Hemoglobin A1c (HbA1c) results can accurately reflect blood glucose levels for the past 2-3 months.
- This test shows if changes are needed in how the Member manages their blood sugar levels.

Why is this test important?

- Hemoglobin is found in red blood cells, which carry oxygen around the body. When there is too much sugar in the blood, it mixes with hemoglobin.

What are the rewards?

- Members with an HbA1c test completed and a controlled A1c value of <8.0% earn a \$25 gift card.

Diabetic Eye Exam

What is a diabetic eye exam?

- Members complete a yearly diabetic retinal eye exam.
- This exam helps find eye problems caused by high blood sugar.

Why is this test important?

- High blood sugar can harm the blood vessels in the retina. The retina is the part of the eye that detects light and sends signals to the brain through the optic nerve.



- Getting regular diabetic eye exams can help catch problems early and prevent vision loss from conditions like diabetic retinopathy.

What are the rewards?

- Diabetic Members can complete the annual eye exam needed for a \$25 gift card.

How can we participate in the Diabetes Rewards program?

Step 1: Qualifying Molina Members will complete their diabetic test/exam before 12/31/2025.

- ✓ Hemoglobin A1c (HbA1c) test completed and a controlled A1c value of <8.0% annually.
- ✓ Diabetic eye exam annually.

Step 2: After completing your test/exam, visit the “Member Rewards” Page for information on reporting your visit(s) and how to select your gift card. This must be completed by 1/31/2026 to claim a 2025 reward. Provide updated contact information to ensure proper delivery of the reward(s).

Step 3: Molina will send your Gift Card(s) for your completed Hemoglobin A1c (HbA1c) test and/or diabetic eye exam within 6-8 weeks of receipt of the bill from your provider and receipt of a reward form.

Incentive Eligibility Requirements

The following requirements must be met to receive the incentive:

- Members must schedule and receive recommended screenings within the service’s required timeframe and notify Molina before 1/31/2026.
- Members must be enrolled with Molina Healthcare of Illinois at the time services were completed to qualify for the reward(s).
- Members may not receive more than one incentive for the same service in a measurement year.
