### **COVID-19 Skilled Nursing Facilities Guidance**

This is an advisory notification to Molina Healthcare of California (MHC) network providers regarding COVID-19 Skilled Nursing Facilities Guidance.

California Department of Public Health (CDPH) provides Skilled Nursing Facilities (SNF) with expectations to implement Coronavirus Disease 2019 (COVID-19) interim guidance for all residents. Elderly persons and those with chronic medical conditions may be at higher risk for severe illness and death from COVID-19.

All California SNFs should take steps to:

- 1. Prevent introduction of COVID-19 into their facility;
- 2. Detect COVID-19 in their facility;
- 3. Receive residents with suspected or confirmed COVID-19 infection;
- 4. Care for residents with suspected or confirmed COVID-19 infection; and
- 5. Prevent spread of COVID-19 within their facility.
