

# **Well-Baby Visit Rewards Program**

#### Who is eligible for the Well-Baby Visit Reward program?

HealthChoice Illinois Members who are between 0-30 months old

#### Why should we participate?

- ✓ Parents of children who receive routine Well-Baby Visits help to improve their baby's overall health.
- ✓ Parents will be informed of the baby's developmental milestones and provided an opportunity to receive necessary immunizations.
- ✓ Members who qualify and take their babies 15 months and younger to 6 or more Well-Baby Visits may earn a \$10 Gift Card per visit (up to \$60 per year)!
- ✓ Members who qualify and take their babies who are 15-30 months old to 2 or more Well-Baby Visits may earn a \$10 Gift Card per visit (up to \$20 per year)!

## **Well-Baby Visits**

### Why are they important?

- Well-Baby Visits allow a doctor to track the growth and development of each baby.
- Each visit provides an opportunity to measure progress and make sure the baby gets the care they need to stay healthy.

#### When does my baby need their appointments?

- All babies should have 6 or more Well-Baby Visits with a PCP during their first 15 months of life.
- All babies should have 2 or more Well-Baby Visits with a PCP between 15-30 months of life.

#### What are the rewards?

- Babies 0-15 months old can earn a \$10 Gift Card per visit (up to \$60 per year)
- Babies 15-30 months old can earn a \$10 Gift Card per visit (up to \$20 per year)

# How can we participate in the Well-Baby Visit Reward program?

**Step 1:** Qualifying Molina Members will complete Well-Baby visits during the required timeframes:

- ✓ 6 or more Well-Baby Visits in the first 15 months of life
- ✓ 2 or more Well-Baby Visits between 15-30 months of life

**Step 2:** After your baby's appointment(s), visit the "Member Rewards" Page for information on reporting their visit(s) and how to select a gift card. This must be completed by 1/31/2024 to claim a 2023 reward. Provide updated contact information to ensure proper delivery of the reward(s).



**Step 3:** Molina will send your Gift Card(s) for taking your baby to their required Well-Baby Visits within 6-8 weeks of receipt of the bill from your doctor and receipt of a reward form.

# **Incentive Eligibility Requirements**

The following requirements must be met to receive the incentive:

- Members must schedule and receive recommended screenings within the service's required timeframe.
- Members must be enrolled with Molina Healthcare of Illinois at the time services were completed to qualify for the reward(s).
- Members may not receive more than one incentive for the same service in a measurement year.
