## <u>Government Programs Which Assist Seniors</u>

The Office of Services to the Aging is the government agency in Michigan that plans, coordinates, and administers senior services and is primarily responsible for advocating on behalf of seniors. It works to enhance the lives of senior citizens by administering and funding numerous state programs. ## <u>Home Preservation / Energy Group — Macomb residents</u> (Weatherization program)

## Eligibility

- Services are no-cost for homeowners who qualify. For those who rent the landlord must pay 40%.
- Must meet current Federal Income Guidelines. Income includes gross income of everyone residing in the home at the time of application.
- Recipients of FIP or SI who have received benefits during any of the past twelve months are automatically income eligible.
- · Applicants must be residents of Macomb County.
- Weatherization crews cannot work on any home that is for sale.

Must provide complete proof of income. This could include one or more of the following:

- "Award" letter from Social Security
- Pay stubs with year to date totals
- Letter from applicant's employer
- Unemployment check stubs

## **Internet Essentials**

Low cost program assisting families and seniors with internet services.

\$9.95 a month + Tax

- Eligible families may be able to receive a desktop or laptop computer for \$149.99 + Tax
- Must be 62 years or older. Or you may qualify if your child is eligible for the National School lunch program, also those who receive HUD housing assistance may also qualify.
- Must receive federal or state public assistance specific to the area where they reside.
- Must not have outstanding debt to Comcast that is less than a year old. Individuals with outstanding debt more than one year old may still be eligible.
- Must live in an area where Comcast Internet service is available, but not have subscribed to it within the last 90 days.

This is required before a volunteer is assigned to assist with services such as; transportation / help with errands, light housekeeping / meal preparation, maintenance, 2-hour care giver relief and yard work assistance.

# Legal Hotline for Michigan Seniors

The Legal Hotline for Michigan Seniors, staffed by specially-trained attorneys, is available to all Michigan residents 60 years and older regardless of income. Hotline attorneys determine if callers have a legal problem, give legal information at no cost over the phone, and provide brief service such as calling a third party or writing a letter to resolve a legal problem. Problems that cannot be resolved by the hotline are referred to legal aid organizations for low-income clients, legal assistance programs serving seniors, pro bono panels, or to a specially-created panel of attorneys in private practice who agree to charge reduced fees.

The Home Injury Prevention Program installs devices to ensure safety and prevent falls and injuries in the homes of eligible Macomb County seniors.

\*Equipment donations are also accepted\*

A licensed contractor will conduct an assessment, make recommendations and install one or more of the following safety devices:

- Grab Bars
- Shower Chairs
- Transfer Benches
- Handheld Shower Heads
- Toilet Assist Rails
- Raised Toilet Seats
- Indoor and Outdoor Handrails
- Smoke Alarms

The suggested contribution is \$10 per device and \$10 for the safety assessment.

## **Temporary Modular Ramps**

Macomb Community Action installs temporary modular aluminum ramps on a short-term basis for disabled seniors. When the ramps are no longer needed, they are removed and used for new participants. The number of ramps are limited. A waiting list is maintained for this project. There is a nominal monthly lease fee for the ramps.

- Macomb County resident
- Age 60 and older
- One-time service
- \*\* Some services are currently waitlisted\*\*

Items are available on a first come first serve basis. It is recommended that you call the office first at (586) 469-5228 to inquire if the equipment that you need is available.

#### Senior Chore Program

#### Eligibility:

- Macomb County resident
- Age 60 and older
- Must be income-eligible

#### Services:

- Snow Removal Runs November through March and is performed after snowfall of two or more inches. Under normal conditions, snow is cleared within 48 hours after snowfall has stopped.
- Lawn Care Grass cutting begins in April or May and continues until October.

#### Cost:

It is suggested that the senior make an appropriate contribution to share in the cost of providing the service. Your suggested donation is based on your yearly gross income and house size using the cost-share sliding scale shown below. Individual assets, property or savings are not considered when determining the amount.

- Any person age 18 or older who resides in the household can apply for assistance
- Applicant must provide proof of identity, residence and a copy of his/her Social Security card
- · Residence must be applicant's primary residence, not a commercial account
- · The Social Security number for every member in the household must be provided

- Applicant must be a US citizen or qualified alien. Immigration status of household members who are not US citizens must be verified and documented
- Total income in the household must be at or below 150% of the federal poverty guidelines (see table below) Proof of income from the past 30 days must be provided for all members of the household who have income
- Maximum payment is \$3,000 for a combined natural gas and electric account or \$1,500 for a single utility (heat or electric)
- A shut-off notice is <u>not</u> required however the bill must be past due. For propane and fuel oil customers the fuel tank must contain no more than 25% of its heating fuel capacity
- If enrolled in DTE's LSP, Consumers Energy's CARE or SEMCO's MAP: not eligible for assistance with the utility in which you are enrolled

To qualify, your household income must be equal to or less than 300 percent of the Federal Poverty Level (FPL)
  - The SEMCO MAP offers a reduced monthly payment based on your income and usage.
  - The program will pay the difference between the plan amount and monthly bill.
  - Past due balance forgiveness. No late fees and service is protected from disconnection during enrollment.
- B. DTE Low Income Self Sufficiency Program (LSP)
  - The DTE LSP offers a reduced monthly payment based on your income.
  - The program will pay the difference between the plan amount and monthly bill.
  - · Past due balance forgiveness.
