### Who is Eligible?

- Full name,
- ProviderOne ID Number,
- Date of birth,
- Date you or your child got the flu shot, and
- Gift Card Option (Walmart or CVS)
- The mailing address where you would like to receive your Gift Card.

This reward is in addition to the \$200 yearly reward maximum available to Apple Health members.

Submit all required information by March 31, 2024.



### When?

Please allow 4-6 weeks after submission for physical gift card to be mailed.

**Note:** To earn the reward, you must have Molina Healthcare of Washington as your primary insurance at the time of receiving your flu vaccine. Molina Apple Health members ages 6 months and older are eligible for this reward. You must receive the vaccine between September 1, 2023 and February 29, 2024. Services done prior will not be eligible for the reward. Reward forms must be submitted by March 31, 2024. Please allow 4-6 weeks after the required information has been sent to Molina to receive your gift card in the mail. If all required information is not provided, the reward will not be fulfilled.
