

Flu Vaccine Reward



Limited Time Reward

Only for Molina Apple Health (Medicaid) Members

Molina Healthcare is pleased to reward Apple Health members with a **\$50 reward** for receiving their flu vaccine (shot) on or between September 1, 2025 and April 30, 2026!

Reminder: Babies receiving their first flu shot need two doses, at least four weeks apart, for full protection — recommended before age 2.



Who is Eligible?

Apple Health members (ages 6 months and older) who receive their flu vaccine **on or between September 1, 2025 – April 30, 2026.**

(Note: Members must have Molina Healthcare of Washington as their primary insurance when they receive their vaccine.)



How to Redeem?

- Log in to your My Molina® member portal account at Member.MolinaHealthcare.com
- Click on the “My Wellness” tab, then click the “My Healthy Rewards” tab
- Click on the “Request Submission” button to view the secure online form
- Fill out the form with details of the flu vaccine you have completed
- Click the “Submit” button, and you’re done!

Note: Rewards can be submitted under either an individual’s My Molina® member portal account or under the primary insurer’s account. If you do not have an account, you will need to create one or call Molina Member Services at (800) 869-7165 (TTY: 711), Monday – Friday, 7:30 a.m. – 6:30 p.m., local time for help claiming your reward.

This reward is in addition to the \$200 yearly reward maximum available to Apple Health members. **Submit all required information by May 31, 2026.**



When?

You will receive your reloadable reward card in the mail with a welcome letter outlining additional information about your card (please allow 2 to 4 weeks for delivery). If you have already received your card, it will be reloaded with the reward amount (allow 1 to 2 weeks).

Note: You must receive the vaccine on or between September 1, 2025 and April 30, 2026. Services done prior will not be eligible for the reward. Vaccine details must be submitted by May 31, 2026. **The reward will not be fulfilled if all required information is not provided.**
