The My Care program is designed to provide patient and family-centered palliative care services to eligible members. The goal of the My Care program is to provide palliative care services to optimize member's quality of life by anticipating, preventing, and managing side effects of their treatment. As part of this program, MHC Case Management will facilitate care coordination by working collaboratively with the palliative care vendor, treating physicians and additional individuals who make up the member's care team.
