PHYSICIAN OFFICE LABORATORY TESTS

This is an advisory notification to Molina Healthcare of California (MHC) network providers regarding an update to allowed physician office laboratory tests, effective May 15, 2018.

OVERVIEW

As a participating MHC provider, you are required to submit laboratory specimens to in-network Independent Clinical Laboratories ("Independent Lab"). This requirement ensures that laboratory services are provided by a credentialed laboratory in the most cost-effective manner, and ensures that MHC has access to laboratory data needed to measure performance quality and outcomes related to HEDIS.

REQUIREMENT

Effective May 15, 2018, Molina will allow only the tests listed in the attached "In Office Laboratory Tests" document in the physician's office, for <u>all lines of business</u>. All other Medically Necessary laboratory testing must be directed to an Independent Lab by the ordering physician.

The following tests were approved on a go-forward basis to be allowed for payment in the physician office setting (POS 11):

Urine Drug Testing: CPTs 80305 and 80306 (Note: per CMS, the only Clinical Laboratory Improvement Amendments (CLIA) waived test is 80305. Due to the lower complexity and low cost of the 80306 test, MHC is opting to allow this test along with 80305.
