PAY-FOR-PERFORMANCE/HEDIS[®] PERFORMANCE BONUS PROGRAM

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

Effective immediately, the following measures have been removed from the 2019 HEDIS P4P Program:

- **Comprehensive Diabetes Care- Retinal Eye Exam**
- **Comprehensive Diabetes Care- Blood Pressure Control**
- **Children Immunization Status- Combo 3**

Effective immediately, the following measures have been included in the 2019 HEDIS P4P Program:

- **Childhood Immunization Status- Combo 10**
- **Asthma Medication Ratio- Total 5-64 years Ratio >0.50**
- **Cervical Cancer Screening- (Sacramento/Riverside/San Bernardino Counties only)**
- **Adolescent Well Care Visits**

Effective October 1st, 2019, Quarter 4 payments for the Well Child Visits (W34) measure will be made based off of final rate and NCOA Quality Compass HEDIS benchmarks that are released yearly in October. For Well Child Visits (W34) final rate achieving the 50th Percentile and above, payment will be paid at one hundred percent. For final rate achieving the 25th Percentile, payment will be paid at fifty percent. For final rate not achieving the 25th Percentile, no payment will be issued.

Well Child Visits 34	\$75 per visit /up to one payment per member per year for children ages 3-6 years old. Effective October 1 st , 2019, Quarter 4 payments for the Well Child Visits (W34) measure will be made based off of final rate and NCQA benchmark achieved. For final measure rate achieving the 50 th Percentile and above, payment will be paid at one hundred percent. For final rate achieving the 25 th Percentile, payment will be paid at fifty percent. Timeliness of Prenatal Care-First Trimester Visit	\$300 per visit /up to one payment per member per year
Timeliness of Post-Partum Care (21-56 days post- delivery)	\$200 per visit /up to one payment per member per year

Asthma Medication Ratio- Total 5-64 Years Ratio >0.50	\$50 will be paid per compliant eligible member. For final measure rate achieving the 50 th Percentile and above, payment will be paid at one hundred percent. For final rate achieving the 25 th Percentile, payment will be paid at fifty percent. For final rate not achieving the 25 th Percentile, no payment will be issued.

Cervical Cancer Screening	\$50 will be paid per gap closed during the 4th quarter. For final measure rate achieving the 50 th Percentile and above, payment will be paid at one hundred percent. For final rate achieving the 25 th Percentile, payment will be paid at fifty percent. For final rate not achieving the 25 th Percentile, no payment will be issued.
Adolescent Well Care Visits	\$25 will be paid per gap closed during the 4th quarter. For final measure rate achieving the 50 th Percentile and above, payment will be paid at one hundred percent. For final rate achieving the 25 th Percentile, payment will be paid at fifty percent. For final rate not achieving the 25 th Percentile, no payment will be issued.
