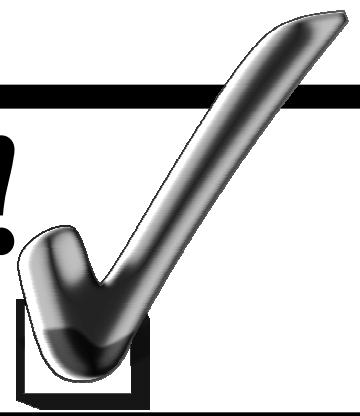

### New Enhanced Benefits Effective December 1, 2021

Effective December 1, 2021 Molina Healthcare of Florida will be adding services to our Expanded Benefits Guidelines.

The new services are listed below:

#### Services Added:

- ✓ **Biometric Equipment** – *All Lines of Business*
  - One (1) Digital blood pressure cuff every three (3) years; One (1) weight scale every three (3) years. *Prior Authorization required.*
  
- ✓ **ALF Move-In Basket** - *LTC only*
  - Members can select up to \$50 worth of items; For LTSS Members currently living in an ALF and new members transitioning/moving into an ALF. *No Prior Authorization required.*
  
- ✓ **Caregiver Transportation** - *LTC only*
  - 4 one-way trips (for caregivers) monthly to visit a member who is residing at an ALF; For LTSS Eligible Caregivers who need transportation to see loved ones in an ALF. *No Prior Authorization required.*
  
- ✓ **Healthy Living Benefit** - *LTC only*
  - Healthy Lifestyle aids for LTC members- Includes a wide variety of assistive devices and adaptive aids to help members maintain independence in their homes. Members can select two (2) from the following items to achieve better health, digital scale, home blood pressure cuff, peak flow meter, reachers/grabbers, lumbar pillow, personal fan, clip on lamp, walker bag, a pair (2) face mask. For LTSS Members (1 lifetime benefit) choose two (2) items. *No Prior Authorization required.*

- ✓ **Legal Guardianship - MMA only**
  - Maximum of five hundred dollars (\$500) per eligible enrollee per lifetime, with prior authorization. This is available to Members who are in a SNF or PDN setting, and parent is obtaining guardianship to protect individuals who are unable to care for their own well-being. Available for members aged 17 through 18.5. *Prior Authorization required.*
  
- ✓ **Flu/Pandemic Prevention Kit – MMA & Specialty Plan only**
  - 1 Flu/Pandemic Prevention kit; 3 ply face masks – 10 piece; Oral digital thermometer; hand sanitizer; Eligible for the first 1000 members who have received their flu vaccine (Must be requested by CM). *No Prior Authorization required.*
