

# Provider Memorandum

## CMHC Subspecialties

Effective September 1, 2019, Molina Healthcare of Illinois (Molina) will require Community Mental Health Center (CMHC) and Behavioral Health Center (BHC) providers to be enrolled in the subspecialty that corresponds to the billed service as shown in the chart below.

This chart is not an all-inclusive list\* of behavioral health services. The purpose of the chart is to identify specific services that require a subspecialty enrollment in the HFS IMPACT system to receive payment from Molina. Providers not enrolled in the subspecialty that matches the billed service will not receive reimbursement.
