

Provider Memorandum

Important Updates to Molina Healthcare of Illinois Prior Authorization Requirements

Effective April 1, 2019, some services related to applied behavioral analysis, behavioral health, durable medical equipment, experimental and investigations procedures, genetic counseling and testing, neuropsychological tests and specialty pharmacy, along with other services will require prior authorization. This change will be reflected on the Molina Healthcare of Illinois (Molina) Prior Authorization Codification List.

Providers are encouraged to review the Prior Authorization Codification List, available online at www.MolinaHealthcare.com. Providers may also visit www.MolinaHealthcare.com for the Current Procedural Terminology (CPT) and Healthcare Common Procedural Coding System (HCPCS) codes that require a prior authorization. Providers may access the document by clicking on “I’m a Health Care Professional” and then clicking the “Frequently Used Forms” tab and searching the “Prior Authorization” section.
