Additional Prior Authorization Requirements Beginning July 1, 2017

Effective July 1, 2017, Molina Healthcare of Illinois will require prior authorization for some specialty pharmacy, home care and home infusion, outpatient hospital procedures and genetic counseling and testing. The updates will be reflected in the Molina Prior Authorization Codification List.

Requests for prior authorizations for these provider-administered medications must be faxed to (866) 617-4971, using the attached [Medical Prior Authorization Form](#). Please review the "Prior Authorization Codification List," available online at www.MolinaHealthcare.com for a comprehensive listing of the Healthcare Common Procedure Coding System (HCPCS) codes that require a prior authorization.
