Emergency Room: cost sharing (note: for non-emergency use of the ER, see below)	\$15.00	\$0.00
Emergency Room: Non-emergency use of the Emergency Room	\$50.00	\$8.00
Brand Name Drugs *: Unnecessary use of a brand name drug not otherwise on the Molina Prescription Drug List	\$5.00	\$3.00

\*The unnecessary use of a brand name drug not on the Molina Healthcare Prescription Drug List (PDL) fee of \$3.00 is NOT in addition to the prescription drug copayment for each respective line of business.
