Quality Initiative 2023

- **What? Molina Healthcare of Nevada Commitment to Wellness Push 2023** – Providers will receive a \$15 bonus on each Annual Wellness Visit completed for a Molina member who has not had one of these codes used in 2023
- **When?** August 15th, 2023 – December 31, 2023
- **Who?** All Molina Medicaid Members in Nevada who have not completed an Annual Wellness Visit in 2023 (whether or not they are on your member panel)
