Billable Code	Can be billed separately?	Modifier or other requirement
99406 – Individual Tobacco Counseling (greater than 3 and up to 10 minutes)	Y	25 modifier
99407 – Individual Tobacco Counseling (greater than 10 minutes)	Y	25 modifier
S9453 – Smoking Cessation classes, non-par physician provider, per session	Y	No modifier required
99406 and 99407 – Federally Qualified Health Centers (FQHC)/ Rural Health Clinics (RHC)	Y	25 modifier - FQHC's are reimbursed using Appendix DD FS from ODM and not the T1015 code with corresponding modifier
D1320 – Dental/FQHC – Tobacco counseling for the control or prevention of oral disease	Y	No modifier required – dental services rendered by dental providers are payable under our dental vendor

Molina's Formulary Coverage for Smoking Cessation includes the medications listed in the chart below. All these medications require a prescription.

NICOTINE PATCH	No PA	No PA
NICOTINE INHALER	PA Required	Trial of Nicotine gum, Lozenge, patch or Bupropion
NICOTINE NASAL SPRAY	PA Required	Trial of Nicotine gum, Lozenge, patch or Bupropion
