### Provider Incentives



The Quality Incentive Program will offer incentive payments for specific services completed for Molina members by September 30, 2018.

#### PROVIDERS MAY EARN \$35 FOR EACH OF THE FOLLOWING SERVICES:

- Well Visit for the Third, Fourth, Fifth and Sixth years of life
- Comprehensive Adolescent Well Care Visit
- Weight Assessment and Counseling for Nutrition and Physical Activity
- Cervical Cancer Screening
- Chlamydia Screening

If your contract contains any Quality Incentive language, you are not eligible for this incentive. Please reference your contract for further information.

### Member Incentives



**WELL VISIT REWARDS** - Members must complete a comprehensive well care visit each year. Include conversations about the member's height, weight, BMI, diet, physical activity and blood pressure (if applicable) during the visit. **Members earn a \$10 CVS Select Gift Card.**



**ADOLESCENT WELL CARE: AGES 12-21** - Members must complete a comprehensive well care visit each year. Include a record of the member's height, weight, body mass index percentile, counseling for nutrition and physical activity, during the visit. **In addition to the \$10 CVS Select Gift Card, members earn a \$15 Subway Gift Card and will also be entered into a drawing to win a \$150 Foot Locker Gift Card.**



#### **WOMEN'S HEALTHY REWARDS** -

Women within the eligible populations for these HEDIS measures:

- Breast Cancer Screening
- Cervical Cancer Screening
- Chlamydia Screening

**Members earn a \$25 CVS Select Gift Card for each service, up to \$75.**

**PRENATAL CARE** - Members should complete their 1st prenatal visit within the 1st trimester and another visit within the 2nd trimester. **Members earn a \$25 CVS Select Gift Card for each appointment, up to \$50.**



**POSTPARTUM CARE** - Members must receive an exam 21-56 days after delivery. **Members earn a \$25 CVS Select Gift Card.**



**NEW BABY REWARDS -**

- **Well Visits:** Members must complete six well child visits before turning 15 months old.
- **Child Immunizations:** Members must complete all required vaccinations before the child's second birthday.

**Members earn a \$25 CVS Select Gift Card for meeting each of these requirements, up to \$50, and will also be entered into a drawing to win a \$150 Babies "R" Us Gift Card each time when the requirements are completed.**



**DIABETES REWARDS** - Eligible members with diabetes (type 1 and type 2) must complete the following exams:

- Receive an HbA1c test
- Receive a nephropathy screening
- Receive a retinal eye exam from an optometrist or ophthalmologist
