

Medicare Opioid Treatment Program (OTP) Part B Benefit Overview

Introduction

Effective January 1, 2020, opioid use disorder (OUD) treatment services provided by Opioid Treatment Programs (OTPs) will be covered as a Medicare Part B benefit (Medical Insurance).

Under the Calendar Year 2020 Physician Fee Schedule final rule, the Medicare Part B Insurer will pay Opioid Treatment Programs through bundled payments for OUD treatment. For dually eligible beneficiaries (those enrolled in both Medicare and Medicaid) who currently get OTP services through Medicaid, as of January 1, 2020, the primary payer for OTP services will be the Medicare payer, including the Molina products listed below.

Medicare Part B Coverage Details

OTP Benefits:

- FDA-approved opioid agonist and antagonist medication-assisted treatment (MAT) medications
 - o Buprenorphine: For acute and chronic pain in addition to opioid dependence
 - Methadone: For management of severe pain in addition to opioid dependence
 - Naltrexone: To treat alcohol dependence in addition to OUD
- Dispensing and administration of MAT medications (if applicable)
- Substance use counseling
- Individual and group therapy
- Toxicology testing
- Intake activities
- Periodic assessments

Additional Provider Information

OTP Provider Requirements:

In order to bill and receive payment from Medicare for opioid use disorder treatment services at an OTP facility, the OTP provider must be:

- 1. Certified and accredited by SAMHSA and,
- 2. Enrolled in the Medicare program as a Medicare OTP provider
