2025 New Women's Health Quality Incentive Expansion

BACKGROUND:

Passport promotes early adoption of annual gynecological care to improve rates of women's screenings for chlamydia and cervical cancer as well as effective pregnancy care. Members who had a visit with women's health provider as defined below prior to pregnancy had significantly higher rates of timely prenatal and postpartum care than those who did not have a visit with a women's health provider.

Passport will offer a new women's health provider quality incentive opportunity – Enhanced fee schedules for annual well woman visit with a GYN/OB/OBGYN/APRN specialized in obstetrics and gynecology/APRN Midwife provider for female member ages 16 to 24-year-old

NEW INCENTIVES:

Passport will pay an **additional \$50** for one (1) annual well woman visit with a GYN, OB, OBGYN, or APRN specialized in obstetrics and gynecology /APRN Midwife for female members aged 16 to 24-year-old. This quality incentive will be paid for date of service (DOS) **8/1/2025-12/31/2025**

FREQUENTLY ASKED QUESTIONS:

- **Who will qualify for the expanded incentives?**

All participating GYN, OB, OBGYN, or APRN specialized in obstetrics and gynecology/
APRN Midwife that complete the above services and submit them on a claim will
qualify for the incentive.

- **How will a provider get paid?**

The expanded incentive will be set up a claim edit within our system. However,
reimbursement depends on the type of contract a provider has with Passport.

If a provider/practice has a standard FFS contract, they will receive the additional \$50 incentive when they are paid on each claim.

If a provider/practice is an FQHC or RHC and receives a wrap payment, they will be paid an annual 2025 lump sum incentive payment in early 2026

- **If the practice is an FQHC or RHC, how will they know how much they have earned so far in the year?** The quality team has a YTD report that tracks how many claims an FQHC or RHC has submitted. The report will be shared quarterly with practices engaged with quality.
- **Is there a limit based on rendering multiple services or between providers throughout the year?** Incentive is limited to one (1) qualifying visit between 8/1/2025 to 12/31/2025 for appropriately aged members with a participating GYN, OB, OBGYN or APRN who specializes in obstetrics and gynecology/APRN Midwife.
