

Diabetes Care Rewards Program

Who is eligible for the Diabetes Care Rewards program?

HealthChoice Illinois Members between the ages of 18-75 that have been diagnosed with diabetes, type 1 or type 2.

Why should I participate?

- Effectively managing diabetes may improve your overall health and **reduce the risk for heart disease and stroke.**
- Members who qualify and complete certain health visits may earn a **\$50 Walmart gift card for each test!**

Hemoglobin A1c Testing

Why is it important?

- Hemoglobin is found in red blood cells, which carry oxygen throughout the body. When diabetes is not controlled (blood sugar is too high), sugar builds up in the blood and combines with hemoglobin. Hemoglobin A1c (HbA1c) results can accurately reflect blood glucose levels for the past 2-3 months. This test gives an indication of whether any changes should be made to your treatment for blood glucose control.

When do I need it?

- This test should be completed at least annually.

What is the reward?

- \$50 Walmart gift card



Monitoring for Nephropathy

Why is it important?

- Nephropathy screening consists of a urine test to screen for kidney disease. Kidney disease is one of the most common complications of diabetes. As with other diabetic complications, the sooner it is diagnosed, the more easily it can be treated.

When do I need it?

- This test should be completed at least annually.

What is the reward?

- \$50 Walmart gift card



How can I participate in the Diabetes Care Rewards program?

Step 1: Qualifying Molina Members will be mailed a pre-paid incentive reply postcard with a qualifying service listed and requirements to earn your reward. Complete each important lab test or screening **by December 31, 2020.**

Step 2: After completing the service, fill out and return the Molina pre-paid incentive postcard with information about your visit(s). Be sure to provide updated contact information to ensure proper delivery of the reward.

Step 3: Molina will send you a \$50 Walmart gift card for each completed service within 6-8 weeks of receipt of the bill from your provider and returned incentive postcard.

Incentive Eligibility Requirements:

The following requirements must be met in order to receive the incentive:

- Members must schedule and receive recommended screenings within the service's required timeframe.
- Members must be enrolled with Molina Healthcare at the time services were rendered to qualify for the reward.
- Members must not have received another incentive award for the same service during the measurement year.
