



**Re: Molina’s Vendor for Incontinence Supplies Effective May 1, 2020**

Dear Provider:

Molina Healthcare of Texas (Molina) conducted a Request for Proposal in the summer of 2018 for a sole-source vendor for incontinence supplies for eligible Molina [Medicaid, CHIP, and MMP] members in Texas.

This letter will serve as your notification that Molina will move to Longhorn Health Solutions for incontinence supplies for all eligible members effective May 1, 2020.

Over the next several months, we will transition all eligible Molina members currently receiving incontinence supplies to longhorn Health Solutions. As part of the transition, all Molina members currently receiving incontinence supplies will receive information regarding the new vendor and the transition process.

“Incontinence supplies” includes the HCPCS codes in the following table. If you provide services other than incontinence supplies under your agreement with Molina, you can continue to supply these non-incontinence supplies.
